Eligibility Requirements

- High School juniors with a 3.0 minimum GPA are eligible with no letter of recommendation.
- High School juniors with a 2.5—2.99 minimum GPA (required signature of high school Dual Credit Counselor and parent on "intent to enroll" (ITE) and a letter of recommendation from principal.
- Student must have either ACT scores or Accuplacer scores; placement scores determine the courses in which the student is eligible to enroll.
- Student must sign an agreement to take two (2) college courses per semester while in the program and to successfully complete courses to remain in the program.

Submission Requirements:

- 1. Letter of recommendation from the high school principal or counselor (if applicable).
- 2. Essay response from the student on why this is important and how they will benefit from this scholarship (please see last page).

Students accepted into this program will pay \$75.00 per course and will take two courses per semester starting in their junior year, for a total of 8 courses (Total \$600.00, \$150.00 per semester). Students who successfully complete this program will earn 24 college credits. Students must maintain at least 2.5 GPA which will be confirmed at the end of each semester, financial need will be confirmed annually.
