

MCC CDL-A Program – Blue River East Campus

Next Class: Late January 2026

Location: MCC Blue River East, 21227 MO-78, Independence, MO 64057

Schedule: Monday–Friday, 7 a.m.–5 p.m.

Cost: \$5,000

Class Size: Limited to 4–6 students (first-come, first-served based on completion of all steps)

Transmission Type: Automatic (no manual transmission training)

Enrollment Steps 1-7

1. Meet Federal CDL Requirements

Review requirements: FMCSA CDL Info

2. Age

- Must be 21 or older to drive interstate.
- Students 18–20 may drive only within Missouri.

3. Submit Driver's License

Email a photo of your valid Missouri Driver's License to **get.ahead@mcckc.edu**. (License cannot be suspended, canceled, or revoked.)

4. Apply for Admission to MCC

If new to MCC, complete the Workforce Application:

5. Decide Payment Method

Email your choice to get.ahead@mcckc.edu. Allow 6-8 weeks for Third Party funding approval.

- Self-Pay in Full by day before start or 3-Part Payment Plan paid by course end
- Third-Party Funding (allow at least 8 weeks to complete steps):
 - SkillUP Missouri (SNAP recipients)
 - Full Employment Council

- Vocational Rehabilitation
- Missouri Fast Track

6. Request Motor Vehicle Report (MVR)

Cost: \$12 (paid by student). Report sent directly to MCC.

Read the "Summary of Rights under the Fair Credit Reporting Act" and check the box; click NEXT






Complete the Disclosure and enter your signature in the electronic signature box; click NEXT

Complete information in required sections of application, click next to move through each section. Ensure all sections reflect complete in the review





Select **SUBMIT** to complete application. *Failure to click submit will delay the processing of your screening



- Credit Card payment options: AMEX, Discover, MasterCard or Visa
- Authorized pending payment receipt will be emailed upon submission to email provided in your application

7. Obtain CDL-A Learner's Permit

Cost: \$41 (paid by student).

- Study using the free **CDL Prep App** or CDL Manual (PDF)
- Permit Test includes: General Knowledge, Air Brakes, and Combination Vehicle sections.
- Testing available at any **Missouri State Highway Patrol Examination Station**.
- Email a photo of your permit to get.ahead@mcckc.edu once obtained.

After Completing Steps 1-7

8. Mandatory Orientation

Held 1–2 weeks before class at MCC Blue River East. Bring your driver's license.

9. DOT Physical & Drug Screen

Scheduled by MCC 1–2 weeks before class. Cost is included in tuition.

10. Pre-Class Assignments

Provided at orientation and reviewed on the first day of class.

Additional Frequently Asked Questions

DOT Physical & Drug Screen Requirements

Drivers must meet DOT medical standards (FMCSR Part 391.41). Disqualifications may include:

- Insulin-dependent diabetes
- Uncontrolled high blood pressure
- Cardiovascular or respiratory disorders
- Epilepsy or loss-of-consciousness conditions
- Certain neuromuscular, mental, or psychiatric disorders
- Poor vision (must have 20/40 or better in each eye, with or without correction)
- Inability to hear a forced whisper at 5 feet
- Use of controlled substances or clinical diagnosis of alcoholism

Criminal Background Guidelines

Trucking companies set their own hiring criteria. General guidelines include:

- No DUI in past 5 years
- No felony convictions in past 7 years
- No more than 3 moving violations in past 3 years
- No reckless or careless driving citations in past 3 years

Motor Vehicle Record (MVR) Standards

You may be disqualified or lose driving authorization if your record includes:

Within past 36 months:

- More than 3 moving violations in a year
- Suspended or restricted license (due to moving violations)
- DUI/DWI conviction or administrative alcohol/drug suspension
- Driving without a valid license or during suspension

At any time:

- Failure to stop/report an accident
- · Vehicular homicide or assault
- Pending warrant for arrest
