## **Certificate Paralegal Practice**

### **Full-Time Advising Guide**

The Paralegal Practice Certificate prepares students to perform substantive and procedural legal work under the supervision of an attorney. Paralegals may not provide legal services directly to the public, except as permitted by law. Paralegals work in many different areas of the law. The required degree courses focus on the core knowledge and skills needed by paralegals in all areas. The elective courses allow students to gain knowledge in various legal specialty areas.

Students must apply to and be accepted into the program. Certificate program requires that student have previously completed an Associate of Arts, Associate of Science, or Bachelors Degree from an accredited institution.
