

**USING THIS GUIDE:**

This guide outlines a path for degree completion at Webster University for the **Bachelor of Arts in Management** for students entering with an **Associate of Applied Science degree in Business- Management emphasis** from Metropolitan Community College.

**ABOUT MANAGEMENT MAJOR AT WEBSTER:**

Management is the art of effectively coordinating people and resources to achieve the goals of an organization. Knowledge and skills acquired while studying management theory, reviewing case studies on management functions, exploring internal and external aspects of managerial work and decision-making will position you for advancement in virtually any industry in which you choose to work.

**WEBSTER ADMISSION REQUIREMENTS:**

Applicants to Webster's degree completion programs should have successfully completed an associate degree or at least two years of college-level work (64 semester hours) with a cumulative grade point average (GPA) of 2.5 on a 4.0 scale. Transfer coursework should include at least one college-level writing/composition class and one college-level mathematics course. While the above profile is recommended, each applicant will be given a thorough individual review. When considering an application, Webster looks for evidence of potential for academic success.

*Notes: Application and transcripts should be completed at least one month prior to the desired date of enrollment. Applications submitted less than two weeks before the start of the term may not be reviewed in time for registration for that term. Please contact the Kansas City Metro campus for specific deadlines and entry dates. Students intending to apply for financial aid should note that earlier deadlines are required.*

**IMPORTANT TRANSFER NOTES:**

- Webster has a minimum residency requirement that 30 of the student's last 36 credits must be taken at Webster University. All students must have a minimum of 128 credit hours to graduate.
- A minimum of **18 credit hours** of academic work **must be taken in the Department of Business or Department of Management at Webster University.**
- No more than one course completed with a grade of D may count toward fulfilling the specific requirements of the major. All General Education/GCP courses must be completed with a C-or higher.

- Webster University provides full transfer of coursework successfully completed as part of an associate degree awarded by a regionally accredited institution. While students with associate degrees typically transfer 60-64 credit hours, Webster will transfer in all coursework that is part of the completed associate degree. Transfer of additional lower-division credit beyond the associate degree is restricted. All transfer credit is capped at 98 credit hours.
- All transfer coursework must be college-level (100-level or above) with a passing grade. Pass/Fail courses will count for transfer credit if the student received a Pass. For repeated courses only the second grade will be counted. Incomplete grades are not accepted in transfer. Courses completed with a grade of D have severe transfer restrictions. Formal evaluation of transfer credit is conducted by the Office of the Registrar upon admission to the University.

**WEBSTER DEGREE REQUIREMENTS:**

A minimum of **128** credit hours consisting of the following:

- Applicable University Global Citizenship Program hours
- 36 required credit hours for the major
- Electives

**GENERAL EDUCATION/GLOBAL CITIZENSHIP PROGRAM:**

Webster University requires all baccalaureate students to complete a general education program. The University has implemented a new set of general education requirements. The Global Citizenship Program (GCP) is a set of undergraduate degree requirements and a general education program developed by Webster University faculty to help prepare students to confront global problems and 21<sup>st</sup> century challenges.

Students completing the Associate of Applied Science degree will have previous credits reviewed on a course-by-course basis for applicability to the GCP. See [Webster’s Transfer Equivalency Database](#) for listing of MCKKC courses acceptable toward meeting these requirements.

**ELECTIVES:**

Please keep in mind that any course applied to a minor must be taken at Webster University, with a grade of C- or better.
