Thank you for your interest in the Occupational Therapy Assistant Program.

The Occupational Therapy Assistant Program is accredited by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 6116 Executive Boulevard, Suite 200, North Bethesda, MD 20852-4929. AOTA's phone number is (301) 652-AOTA and the website is www.ACOTEONLINE.org.

Graduates of the program will be able to sit for the national certification examination for the occupational therapy assistant administered by the National Board for Certification in Occupational Therapy (NBCOT) 800 S. Frederick Avenue, Suite 200, Gaithersburg, MD 20877-4150, (301) 990-7979. After successful completion of this exam, the individual will be a Certified Occupational Therapy Assistant (COTA). Most states require licensure in order to practice; however, state licenses are usually based on the results of the NBCOT Certification Examination.

Please note - A felony conviction may affect a graduate's ability to sit for the NBCOT Certification Examination or attain state licensure. The field of Occupational Therapy is exciting, diverse, and rewarding. COTAs work under the supervision of a Registered Occupational Therapist to provide patient care to individuals with varying physical and/or emotional challenges to obtain their maximum level of independence with self-care and daily living skills. A variety of work settings are available such as hospitals, nursing homes, school systems, home health care, and community agencies.

Instructional Model as of April 2023 -

After input from instructional leaders, conversations with medical experts in our community, reviewing our college infection rates, and consulting with other community colleges, universities, and K12 leaders in the state and region, the Administration determined all CTE (Career and Technical Education – including Allied Health) courses, performance/studio-based courses in ART, MUSI, and THEA, and science courses containing a lab (including lecture portions of classes attached to a lab) will continue to operate face-to-face.

The safety protocols that were in place will be reimplemented as needed based on recommendations from the CDC and City Government.

Future protocols may include:

- Face masks are required in all public indoor spaces. Masks are available at designated locations on each campus as identified on signs at building entrances.
- Deep cleaning and sanitization using virucides will continue on a nightly basis with additional cleaning taking place during the workday.
- Increased self-help cleaning kits and hand sanitization stations are available throughout the campuses.

Please know *this policy could change at any time* dependent on guidance from area health officials. In addition, students in **clinical settings** may **still be required to wear a mask regardless of vaccination status**. While not required by MCC at this time, **a significant majority of the clinical sites that are medical-model based are requiring the vaccine with a limited few allowing exceptions**, and to graduate from the program, students must complete clinicals in a range of settings and disciplines. Therefore, although MCC is not currently requiring the **Covid vaccine**, it is strongly recommended. *Additionally, many clinical sites are requiring all students to have completed the full vaccination series.*

The program will take measures to ensure the safety of students while on campus as needed, including PPE available to students such as masks, face shields, goggles, and gloves. Cleaning of supplies and surfaces occurs frequently.

Occupational Therapy Assistant Program General Information

Occupational Therapy as a Career:

- Excellent employment opportunities in a variety of settings

Occupational Therapy Assistant Program Overview:

- Students must apply to and be accepted to the program
- Accredited by the Accreditation Council of Occupational Therapy Education (ACOTE) since 1984
- The program is 2 years in length, once accepted, with a base total of 73 credit hours
- The program is currently full-time only with all classes and outside requirements occurring during the daytime, and weekday hours; clinical experiences will occur during the week overall and during daytime hours also.
- Offers 760 hours of clinical experience
- Excellent reputation for quality education within the healthcare community

Student Requirements once accepted:

- Maintain CPR certification (obtained the first semester of the program)
- Complete physical exam to include TB test yearly (once accepted to the program)
- Submit proof of required vaccinations and maintain a health record
- Receive the annual flu vaccine in both years in early October/late September
- Obtain Hepatitis B vaccination or sign a waiver
- Not have to work the last semester of school during Level II Fieldwork (note – it is recommended that students limit the number of hours worked for increased success in the program throughout)
- Students will be required to submit a drug screen and background check for clinical fieldwork sites. Please see the statement toward the end of the packet regarding this requirement.
- Criminal Background Check (CBC): Clinical sites require that only students with an acceptable consumer report, as it relates to criminal background, be allowed to participate in clinical rotations. Therefore, prior to commencing the clinical portion of your program, all students will be required to conduct a criminal background check. You are responsible for completing the required application information with the reporting agency and paying the cost. Criminal background checks are normally conducted once during the program; however, some clinical sites may require a more current report.

MCC shall not use the results of a background check as criteria for admission to any program or course. However, you should know that you will not be able to obtain a license to practice or be allowed to participate in clinical should you have an unacceptable background as defined by state law regarding health care providers. An unacceptable background includes a felony and/or class "A" misdemeanor conviction. Please note - A felony conviction may affect a graduate's ability to sit for the NBCOT Certification Examination or attain state licensure. - Progression and retention: To receive an AAS degree in Occupational Therapy the student must complete all courses with a grade of "C" or better in each course required for the degree and must successfully pass all laboratory checkouts as outlined in each course syllabus. As well, students are expected to maintain a GPA of at least 2.0 in the program. Progression through coursework is outlined in the curriculum sequence outlined in the course information packet with no opportunity to complete OTA courses in variation of the sequence. Students failing to meet these requirements will be required to reapply to the Occupational Therapy Assistant (OTA) program, and if accepted, retake all OTHA courses in sequence beginning with semester 1 offerings.

- Graduation: Students are required to complete all general education and OTA coursework successfully to graduate. Students will meet with faculty regularly to discuss progression to graduation.
- Certification and credentialing: Graduates of the program are eligible to apply for the National Board for Certification in Occupational Therapy exam as well as for licensure in individual states as allowed by state law. For more information on the exam, see www.NBCOT.org

Answers to Frequently Asked Questions:

- OTA coursework will not transfer to a four-year institution; however, some general education coursework may transfer. The OTA level does not allow you to enter a Master's program to become an Occupational Therapist
- Anatomy and Physiology and Introduction to Occupational Therapy **must** have been taken within the last five years to be accepted
- Completion of all required general education courses before starting in the OTA program would help to "lighten" the student's course load. Completion of the Anatomy and Physiology requirement before application to the program is *strongly* recommended

Note – students who have not taken more than 1-2 science courses, or a full credit hour load, in a single semester will benefit from completing all prerequisites prior to being accepted into the program

- New OTA classes are only accepted once a year to begin the fall semester

- All prerequisites must be completed **PRIOR** to the application deadline on June 15; *however, students completing a prerequisite during the summer semester they apply may be accepted contingent upon passing the summer course with greater than a C*
- The program is full-time with classes meeting during the day most days of the week, excluding weekends. The schedule changes each semester; however, classes generally start at 9:00 AM and end by 4:00 PM. Fieldwork each semester is based on the working schedule of the fieldwork educator so flexibility will be required.
- There are two courses in the OTA program offered via distance education. OTHA 100, a prerequisite, can be taken either in-person select semesters or online through distance education in the Fall, Spring, or Summer semesters. OTHA 103 Clinical Conditions will be completed using a hybrid model with one session weekly on campus occurring within the first semester of the program. Quizzes may/will be taken online and all exams are taken at the institution's testing center, on-campus proctored by program faculty, or proctored remotely utilizing a program requiring a web camera via Canvas, the learning management system. All other courses are in-person and utilize the online Learning Management System for the management of content. Students are required to have regular access to computer technology with up-to-date software, reliable broadband connection to the internet, and the ability to install software that may be required for the course. Technical skills required for online courses include:
 - Access sites and navigate online.
 - Use a word processor (i.e. Microsoft Word) to open and save in common document file formats (accepted formats Word and PDF).
 - Send and receive an e-mail, with a minimum daily review and reply, including attaching and downloading files.
 - Read and post to discussion/messaging boards and blogs.
 - Use a supported browser and adjust browser settings as required.
 - Save a URL as a bookmark/favorite.
 - Perform online searches using Google and other search engines.
 - Cut, paste, and copy information from the internet or files and save it to the computer or other storage device

- Students applying with previous degrees awarded still take the OTA coursework as outlined in the curriculum checklist. The program is 2 years in duration regardless of previous general education coursework taken.
- All students who have not taken placement tests in the past 3 years will be required to take the Accuplacer placement tests to establish their English & reading levels. Even students with a degree will need to take the reading placement test before applying to the program.

Occupational Therapy Assistant Program Application Process

Apply to MCC (for students new to MCC)

- The MCC admission application should be completed online at www.mcckc.edu. Select **Apply** and follow the steps as indicated. Application to MCC is free.
- Arrange for official transcripts to be sent to MCC, Attn: MCC Student Data Center, 3200 Broadway, Kansas City, MO 64111. The Student Data Center will determine course equivalencies and post them to the MCC transcript. **Include** copies of high school transcripts, HiSET/GED, and any college transcripts for the Student Data Center. You do **not** need to send high school transcripts or HiSET/GED reports to the OTA program nor do you need to have an official MCC transcript sent to the program. Transcripts from colleges other than MCC need to be sent to the OTA program as well as the Student Data Center. Please note that it may take a few weeks for transcripts from other colleges to be sent and received. Therefore, do not wait too long to send transcripts as they may not be received by the June 15th deadline and thus affect your application status.
- Arrange for unofficial transcripts to also be sent to the Occupational Therapy Assistant Program, Attn. Lisa Koch OTR, Program Director; 3444 Broadway #410J, Kansas City, MO 64111. To not delay the review of your application
- If you desire Allied Health Advising or Counseling (not required), contact the OTA Program advisor Alex Johnson at MCC by calling 816-604-4687 or Alexandra.Johnson@MCCKC.EDU
- Prior to formal admission to the OTA Program complete a minimum of 11 hours of coursework toward the degree that must include:
 - Achieve placement score minimum if required (see information on next page)
 - **OTHA 100 Introduction to Occupational Therapy (In-person or online)** (2 Cr.)
 - **ANY Biological or Physical Science worth 4 or more credits** (Anatomy and Physiology taken for the program will not also count toward this science requirement)
 - **BIOL 150 Medical Terminology** (2 Cr.)
 - **ENGL 101 Composition & Reading** (3 Cr.)
 - Strongly recommend taking **HLSC 108, Anatomy and Physiology for Health Professions** (or an **equivalent Anatomy & Physiology class with a Lab**) **before beginning** the program instead of waiting for the first semester of the program due to the rigor/difficulty of the course content.

Apply to the OTA Program

- Download the application packet from www.mcckc.edu/occupationaltherapy.
- **Complete a 3-4-page Paper (double spaced, 11 or 12-point font, 1-inch margins)**. The paper will be evaluated for writing skills and will impact your selection for the program. Please note that plagiarism will not be accepted and any sources used should be appropriately referenced. Use the information you gained from OTHA 100 as well as your own research to write this section.
 - Include in your paper the following:
 - a. Your definition of Occupational Therapy and your reasons for choosing the field. Your definition should be complete and well-defined.
 - Include what Occupation means
 - b. Include a discussion of the diverse areas in which an OTA would practice, and which areas of OT you are interested in. Include any experiences you have had with OT either personally or

professionally.

c. Why do you feel you would be a good candidate for the field of OT and the program.

- Complete the **Curriculum Checklist** by identifying the courses you have taken and the grade you received in each course. The minimum GPA for admission is 2.5.
- Copy of your most current **Official Transcripts (non-MCC)** reflecting the courses you have taken that are relevant to your acceptance into the OTA program. Please know it can take a few weeks for colleges and universities to send transcripts and a few weeks as well for the student data center to evaluate them. (see #2) You may include unofficial transcripts or copies of your official transcripts with your application to ensure the program has records.
- The application and paper need to be placed **in an envelope** and sent to the Occupational Therapy Assistant Program, MCC-PV, 3444 Broadway, KCMO 64111, or dropped off to the Division Secretary at the Health Science Institute, HSI 410 at 3444 Broadway, KC, MO by **June 15**.
- **DO NOT** include any additional materials such as letters of recommendation, other essays, etc. These will not be evaluated and will not impact your selection to the program.
- No students will be selected until after the June 15 date. Early application does not guarantee admission to the program. Within 1-2 weeks after June 15th, you may be asked to complete an interview with program representatives. This interview will be scheduled via telephone or e-mail at the program's convenience. Students may be asked to submit an on-the-spot writing sample.
- **A valid e-mail must be provided** on the application as students will be informed of their status with the program via e-mail. Students can expect to learn of their acceptance or non-acceptance within 2 to 3 weeks after June 15th.
- Students accepted into the OTA Program will be invited to an orientation, Program workshop, and fall enrollment session in July. **Do not** try to enroll in any course before this orientation session.
- At the orientation session and OTA Program workshop, students will review the Occupational Therapy Assistant Program Handbook **Recommendations/Policies**, and sign a statement of understanding. The workshop will focus on the student services, supports, and strategies students will benefit from to be successful in the OTA program.

Applicant selection is based on:

- Past and present academic performance, at least 2.5 GPA
- Volunteer and work experience
- Written communication abilities
- Application paper
- Interview and live writing sample

Scores for MCC Health Care Programs

All requirements must be met by all applicants before the start of any given application period.

All applicants **must** have taken the ACT, COMPASS, or ACCUPLACER placement test within the **three years** of the application deadline. Based on scores, the applicant would need to take and pass the indicated courses before they would be eligible to apply to the program. The scores are as follows:

- All applicants **must** have a current (less than three years old) ACT or ACCUPLACER reading score in order to be considered for the program.
- If you completed the required math, writing, and reading courses with at least a “C” letter grade, the courses do not need to be retaken even if you need to retake the ACCUPLACER test.
- If you are a current, returning, or transfer student, and have completed Engl 101 and Math 120 with at least a “C” letter grade, you **only** need to retake the reading section of the ACCUPLACER test if scores are over three years or no previous scores on record.
- If you have completed or tested out of ESL, you are expected to take and complete Read 100 with at least a “C” letter grade or scored 110 on the ESL reading section of the ACCUPLACER test (less than three years old).

The reading and writing requirements of the program are significant, the Accuplacer may indicate a student would benefit from developing strong skills prior to beginning the program.

A Summary of Your Rights under the Fair Credit Reporting Act

Metropolitan Community College Criminal Background Checks (CBCs) for Allied Health, Nursing and Continuing Education Programs

Student Application Packet:

Criminal Background Check (CBC):

Clinical sites require that only students with an acceptable consumer report, as it relates to criminal background, be allowed to participate in clinical rotations. Therefore, prior to commencing the clinical portion of your program, Metropolitan Community College (MCC) will have Validity Screening Solutions, a credit reporting agency, conduct a background check. You are responsible for completing the required application information with the credit reporting agency and paying the cost. **Criminal background checks are normally conducted once during the program; however, some clinical sites may require a more current report.**

MCC shall not use the results of a background check as criteria for admission to any program or course. However, you should know that you will not be able to obtain a license to practice or be allowed to participate in clinicals should you have an unacceptable background as defined by state law regarding health care providers. An unacceptable background includes a felony and/or class "A" misdemeanor conviction.

Drug-Free Workplace, Campus and Community Drug Screen Policy

MCC – Penn Valley is committed to maintaining high standards in all programs including allied health and nursing education and practice. Safe practice includes efficient, reliable, and unimpaired student performance at all times including in the classroom and in a clinical setting. Being under the influence of drugs or alcohol poses serious safety and health risks not only to the user but also to all persons who come in contact with the user. Students are required to perform all education related activities in appropriate mental and physical condition

MCC-PV has adopted the Federal Drug-Free Workplace Act of 1988 and Drug-Free Schools and Communities Act Amendments of 1989. The policy is one of zero tolerance. Together with the college's Drug-Free policy, the Code of Student Conduct imposes prohibited conduct and possible disciplinary action. If in violation of these policies, students subject themselves to disciplinary actions up to and including suspension or expulsion from the college and its programs.

Clinical facilities are committed to providing a safe environment in order to protect its patients, residents, employees and visitors; to provide the highest level of service; and to minimize the potential for accidents and injuries. Therefore, many of the clinical contracts between MCC – PV and hospitals, clinics, and other facilities have a component requiring drug screening for allied health and/or nursing students. The clinical site might require that an MCC – PV allied health and/or nursing student complete and pass a drug screen prior to being admitted into the facility as a student. Additionally, some clinical facilities require random drug testing during the duration of a clinical rotation. Refusal to submit to a drug screen or testing positive can make a student ineligible to participate in clinical training.

The cost for a drug screen may be covered by the clinical facility. If not, the student is responsible for the cost.

OCCUPATIONAL THERAPY ASSISTANT STUDENTS**

Student Responsibilities:

Occupational Therapy Assistants work under the supervision of an Occupational Therapist, helping people with physical, cognitive, social or emotional problems reach maximum independence in daily living skills. OTAs work in a variety of settings: hospitals, schools, out-patient clinics, mental health clinics as well as community agencies and businesses. During your academic experience, you'll be exposed to a very hands-on and interactive learning environment that is both supportive and challenging. Your education also includes fieldwork at varying facilities which will involve direct client contact and involvement with community professionals. Student should consider this responsibility both an opportunity and a requirement.

Students are expected to follow the code of student behavior set by the College and to conduct themselves in a professional, ethical, and responsible manner with other students, faculty, administrators, all program and College facilities, community professionals and clients, equipment, and supplies.

Performance Standards for Successful Completion of the Occupational Therapy Assistant Program:

These Performance Standards should be used to assist each applicant and student to determine if they are otherwise qualified to be an Occupational Therapy Assistant. It is the policy of MCC – Penn Valley to provide reasonable accommodations for individuals with disabilities. **If you need an accommodation due to a disability under the Americans with Disabilities Act**, please contact the Disability Support Services Coordinator at 816-759-4089 or visit the MCC website at www.mcckc.edu/access.html. Two to six week advance notice is required for some accommodations.
