Clarification on Soft Clients with new VoIP Provider	<ul style="list-style-type: none">• Adjusting and learning as we go with UPN.• Biggest point of confusion = Soft clients (Nimbus) smart phone app, not required to use it. Desktop software functionality but, set # of licenses. If exceeded – we must request another batch of licenses and there is a cost associated.• Boomea (full software installation), desktop app for high volume call flows. First come, first serve. Hoping for additional grant funding for better laptops. Students don't have to have any requirements/need to request a laptop, open for any enrolled student. Software is tricky depending on the type of software, different minimum requirements and licensing. Know that it is a need and still figuring out a way forward for students to access 	

	specific academic programming software. JCCC did a demo where students can remote into labs and utilize the specific software they need. Testing, configuration, and engineering is needed, but the feature is being investigated by IT. Can't give solid timeline but would like to see it starting in Fall 2025.
