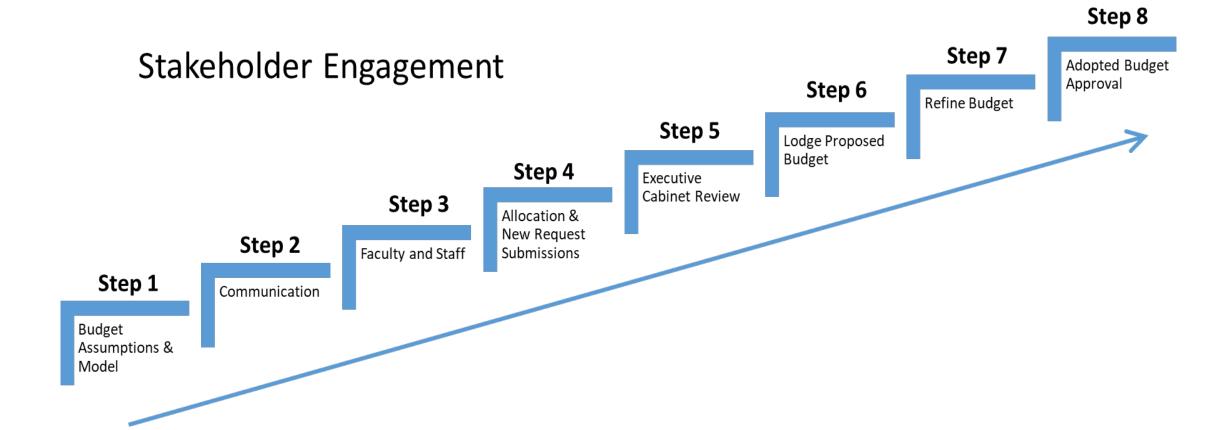

### **Annual Budget Planning Process**

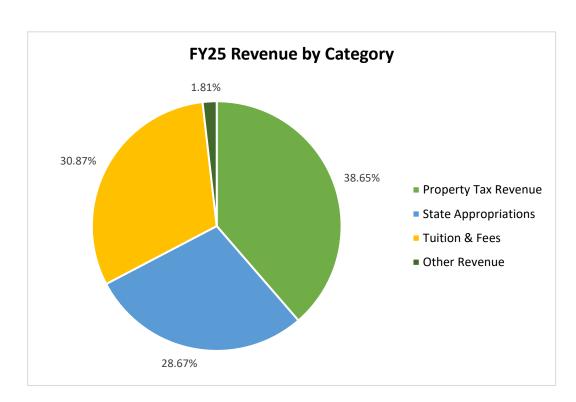


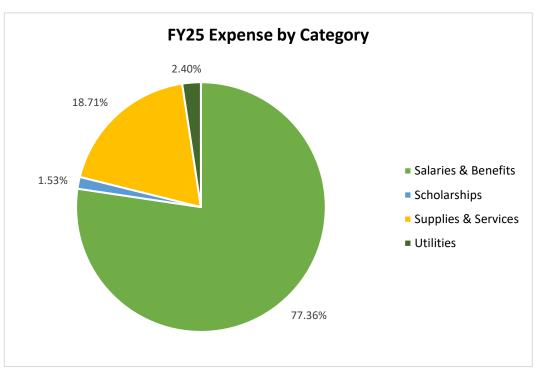

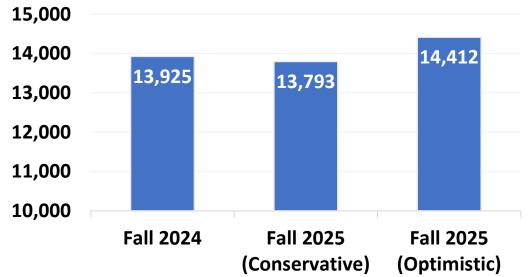

### **Budget Recommendation**

- Based on the projection model, the data shows a conservative projection for Fall 2025 is a 0.9% decrease. The data's optimistic projection is a 3.4% increase.
- Statistical probability shows enrollment will fall somewhere between the conservative and optimistic projection. Therefore, IR recommends budgeting conservatively for flat enrollment, or potentially up to a 1% increase.







### **Enrollment Recommendations (IR)**



Conservative goal—used for budget purposes

Optimistic goal—used for campus enrollment targets.

### FY26 Budget Recommendation

- Budget Model: <u>Incremental</u>
  - FY25 Adopted Budget as starting point
    - Few: Targeted adjustments
      - Increased costs in services
      - New facilities
    - Many: Reallocations recommended
      - Shift budgets from departments that historically underspend to departments that overspend within a campus/service area

## Board Policy (BP), District Regulation (DR) or District Procedure (DP)

#### **Rationale for Recissions**

3.20010 BP Schedule of Salary and Conditions	SS&C provides guidance on HOW certain salary and benefit practices should be carried out. Since they are more <u>operational</u> in nature – we believe they should no longer be a required, Board-reviewed item – based on the Carver model.
3.20010 DR Schedule of Salary	
and Conditions	In addition, this policy and procedure also limit implementing approved SS&C recommendations to only once per year -the May/June Board meeting vs. potentially during the academic year or more frequently – if the update would prove feasible and more beneficial to implement sooner with our Destination Workplace strategy.)

#### **EGS Guidance on Government Funding Pause 1-28-2025**

- Ellucian Grants Services is monitoring information as it is released about the impact of the most recent Executive Orders and the Office of Management and Budget memo ordering Federal agencies to temporarily pause agency grants, loans, and other financial assistance. The pause goes into effect at 5 p.m. ET, on January 28, 2025, and agencies have until February 10, 2025, to complete a comprehensive analysis of all of their Federal financial assistance programs to identify programs, projects, and activities that may be implicated by any of the President's Executive Orders.
- It is unclear how the pause will impact each individual program and agency at this time. During this required pause, we recommend you review your active grant awards and identify those that may be directly impacted by the Executive Orders and the administration's priorities. Most importantly, monitor communications from your program officer.
- We know this is an uncertain time. The following recommendations are intended to help you navigate this interim period. As always, please let us know if you have questions.
- Actively engage with higher education membership and advocacy organizations such as (but not limited to): American Association of Colleges and Universities, American Association of Community Colleges, Council of Independent Colleges, The Council for Opportunity in Education, Association of Community College Trustees, National Association of College and University Business Officers (NACUBO), Excelencia in Education, etc.
- For active awards
  - Contact the cognizant federal funding agency Program Officers with a copy to their respective supervisor (if known) to request guidance and clarifications on impacts on all active grants, including whether
    pauses in activities or funding are anticipated
  - Contact your elected officials about the pause and concerns you have about any of your funded awards
  - o Focus on compliance of funded awards
    - Ensure drawdowns are current and accurate through January 28, 2025
    - Ensure mandatory reporting is up-to-date and accurate
    - Continue to implement activities as scheduled
    - Communicate internally within the institution and with EGS to monitor grant activities from the lens of the new administration
    - Review all funded projects and draft a plan to make anticipated or required modifications to comply with all Executive Orders
    - Respond in a timely manner to funding agency requests for project information or modifications
- For pre-award and grant development activities
  - o Continue planning major grant initiatives; there is always value in planning institutionally transformational projects
  - Review the institutional Funding Roadmap and other funder prospect reports to plan outreach and networking activities with private foundations most closely aligned with the institution's priorities for external funding

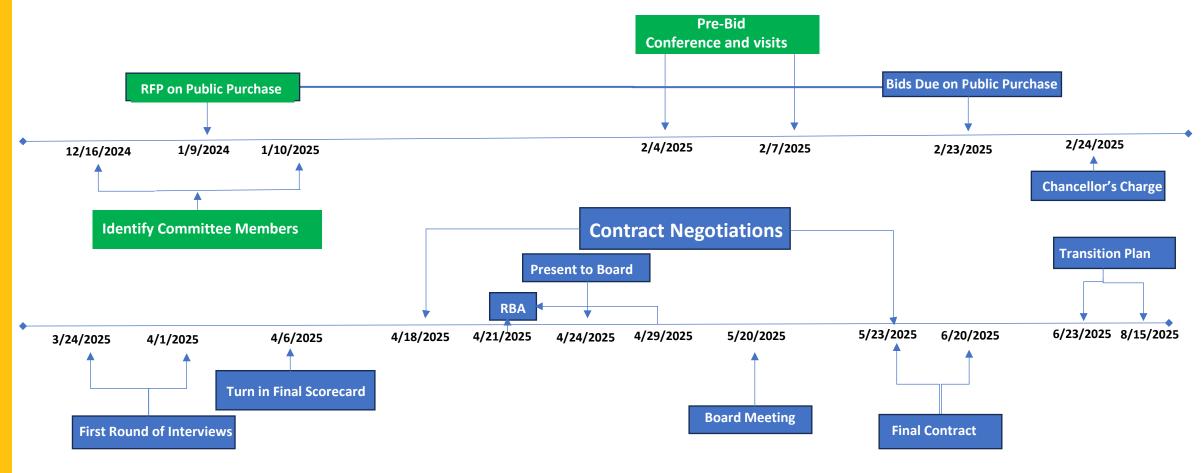
